No carry-over to subsequent billing periods.

Organizations/Companies may not participate in both the **MemberPlus** Referral Program and the **MemberPlus** Affinity Program. **MemberPlus** Affinity program will be discontinued as of 12/31/2009, unless contracted otherwise with CommPartners, and replaced with an offer to participate in the **MemberPlus** Referral Program.
